DATA SUBJECT APPLICATION/REQUEST FORM ON THE PROTECTION OF PERSONAL DATA

INFORMATION .

Pursuant to Article 13 of the Law No. 6698 on the Protection of Personal Data;

'The data subject submits his/her requests regarding the implementation of this Law to the data controller in writing or by other methods to be determined by the Board. The data controller shall finalize the requests in the application free of charge as soon as possible and within thirty days at the latest, depending on the nature of the request. However, if the transaction requires an additional cost, the fee in the tariff determined by the Board may be charged. The data controller accepts the request or rejects it by explaining the reason and notifies the data subject in writing or electronically. If the request in the application is accepted, the data controller shall fulfill the requirement. In case the application is caused by the error of the data controller, the fee charged shall be refunded to the data subject.'

For this reason, as a "data controller" within the scope of the GDPR Law, you can apply to us as the relevant person/applicant within the scope of one of the following options with this form;

The direct applicant must come to the company address below and apply by proving his/her identity by presenting his/her T.R. Identity Card;

- 1. Direct application of the applicant by coming to the address of the Data Controller below and proving his/her identity by presenting his/her T.R. Identity Card;**

- 2. Submitting an application through a notary public or sending a written application to our contact address as Data Controller by registered letter with return receipt;**

- 3. Signing this Request and Application Form with the "secure electronic signature" defined in the Electronic Signature Law No. 5070 and sending it to us by sending it to orimpexas@hs01.kep.tr via Registered Electronic Mail,**

is required.

The above-mentioned remedies are covered by the "written" application pursuant to Article 13, paragraph 1 of the Law. After other methods to be determined by the Board are announced,

the Data Controller will announce to the relevant persons how the applications will be received through these methods.

Pursuant to paragraph 2 of Article 13 of the Law, your applications submitted to us will be answered free of charge "as soon as possible and within thirty days at the latest" from the date of receipt of your request, depending on the nature of the request. However, if the transaction requires an additional cost, the fee in the tariff determined by the Personal Data Protection Board will be charged by the Data Controller. Our responses will be delivered to you in writing or electronically in accordance with Article 13 of the relevant Law.

Depending on the nature of your application and request, the information and documents requested from you must be submitted to us completely and accurately. If the requested information and documents are not provided as required, there may be problems in the full and qualified execution of the researches to be carried out by the Data Controller based on your request. In this case, it declares that it reserves its legal rights as the Data Controller. For this reason, the relevant form must be sent completely and in a manner to include the requested information and documents according to the nature of your request.

INFORMATION ABOUT THE APPLICANT AND INFORMATION ABOUT HIS/HER APPLICATION

In order for us to identify the "applicant" regarding your application and to make the necessary investigations before the Data Controller according to the nature of your request, the following information must be provided.

Your specified contact information is requested in order to obtain more detailed information about your application, to inform you about our review processes and to inform you about the results of your application.

In order to ensure the security of your personal data, within seven (7) days from the date of receipt of your application for obtaining information, we, as the Data Controller, may contact

you to confirm that you are the data subject and may request certain information and documents from you in this regard.

If the information and documents requested from you are incomplete, the information and documents will need to be completed and submitted to us upon our request. Until the information and documents are fully transmitted to us, the thirty (30) day period specified in Article 13/2 of the Law regarding the finalization of the request will stop and will not run.
